RE-TENDER INVITATION

Sub: **Additional plate fixing above the bottom plate of the Hot water tank in Clarification and press area.**

We invite you to submit your quotation for the **Additional plate fixing above the bottom plate of the Hot water tank in Clarification and press area** during **Annual Shutdown maintenance (from 26.12.2024 to 20.01.2025)**, at Palm Oil Mill, Yeroor Estate, Bhartheepuram P. O, Kollam Dist., Kerala by email in PDF format (indicating our enquiry number and due date) to tendersopil@gmail.com on or before the due date on 31.12.2024 up to 02:30 pm and bids shall be opened on same day 03.00 pm.

SCOPE OF WORK:

Additional plate fixing above the bottom plate of the Hot water tank in Clarification and press area.

Details of Work:

1. Cut and remove the required portion of the top cover plate of the tanks.
2. Dismantle the steam coil and its supports from the tanks.
3. Remove all rust particles/deposits from the bottom area and do the inside Surface cleaning by wire brush/ buffing wheel.
4. Fabricate additional 6 mm M.S bottom plate and do the fit up and welding
5. Fabricate additional 6 mm lining plate to the shell portion in all 4 sides (Height 150MM). size of bottom plate for hot water tank in clarification area is 3500 mm x 1800 mm and that of screw press area is 2550 mm x 1340 mm. Thk of the M.S plate is 6 mm.
6. Fix the plates in position and do the welding.
7. Erect steam coil supports.
8. Erect the steam coils and do the proper clamping.
9. Re fit the top cover and do the welding.

Terms and conditions:

1. All materials required for the work will be supplied by OPIL.
2. All Consumables like welding rod, cutting wheel required for the work shall be supplied by OPIL.
3. All Machineries like welding machine, grinding machine, and all tools and tackles, cutting set etc. should be arranged by the contractor.
4. All skilled labours, supervisors required for the work should be arranged by the contractor.
5. 100 % Payment shall be released after completion and Hydro testing.

2. Price:

Amount quoted for the work should be in lump-sum.

3. Cess & GST:

6. Firm Price:

7. Payment terms:

Our payment term is within 15 days after completion of work and certification by In-Charge (Palm Oil Mill).

8. Correction and errors:

Quotation should be free of corrections and errors.

9. Penalty for delay:

Penalty shall be imposed in the form of Liquidated damages at the rate of 0.5% per week or part thereof the value of the Work Order for the delayed

period beyond the stipulated delivery date in the order duly accepted by contractor. This recovery will be limited to 10% of Work Order value.
