Scope of Work:

- 1 Should have valid Class II or above Boiler Repairer /Erecter license issued by the Dept. F&B , Kerala
- 2 Arranging for Material Inspection to be carried out by F&B official.
- 3 Removing of Boiler Tubes (Existing), Grinding, Face cleaning for welding.
- 4 Fitting the tubes as per the existing method.
- 5 Replacing the Boiler tube with new tubes, fitting and welding of both sides.
- 6 Fit-up and Root Welding.
- 7 Filling the root with arc welding and finishing the joints.
- 8 Welding of tubes is done by Approved IBR welder.
- 9 All consumables are in the scope of contractor.
- 10 Entire Formalities for Open test, Hydraulic test and for obtaining PO.

IBR tubes will be provided by OPIL - MRM.

CONDITIONS OF THE TENDER

1. Price:

Rate quoted for should be in Rs / Tube.

2. Cess & GST:

3. Validity of offer:

The rates quoted should be valid for a minimum period of 60 days from the due date.

4. Delivery period:

A firm delivery date/period should be indicated. Delivery period reckoned shall be treated from the date of release of work order or as per intimation from OPIL.

5. Firm Price:

In the event of order price shall be firm till complete execution of the work.

6. Payment terms:

Our payment term is within 15 days after completion of work and certification by In-Charge (Modern Rice Mill).

7. Correction and errors:

Quotation should be free of corrections and errors.

8. Penalty for delay:

Penalty shall be imposed in the form of Liquidated damages at the rate of 0.5% per week or part thereof of the value of the Work Order for the delayed period beyond the stipulated delivery date in the order duly accepted by contractor. This recovery will be limited to 10% of Work Order value.
